Score Cards: These must be collected by the secretary of the club where the ties are being played and forwarded to the **Association Secretary** to arrive no later than **Thursday 15th June 2006**.

Rule: If due to inclement weather play ceases in any part of the Gilmour Trophy after 11 ends, the award will be made on shots scored at the 11th end, provided 30% of the clubs complete 11 ends. Any four failing to complete 11 ends will not be included in the Total Score.

Teas: These must be arranged by the clubs on whose green ties are being played. Each Player will pay for their own tea.

Note: If any four is unable to play, the Secretary of the club concerned, will notify the Secretary of the club on whose green they are drawn to play, and also their opponents. If they do not, they will be liable for the expense incurred by the club that supplied the catering and their opponents expenses if any.
